

MEMORANDUM OF UNDERSTANDING

ARTICLE-I: SCOPE OF THE MOU

ARTICLE-II: SCOPE AND TERMS OF INTERACTIONS

- c) Joint guidance of student projects/thesis in specific areas of the subject domain by PIRAMAL CAPITAL HOUSING FINANCE LTD. on mutually agreeable terms.
- d) PIRAMAL CAPITAL HOUSING FINANCE LTD. may depute its personnel as visiting faculty at KASHI INSTITUTE OF TECHNOLOGY to teach any of the regular Course or specialized topics or keep Expert sessions at regular intervals.
- e) PIRAMAL CAPITAL HOUSING FINANCE LTD. personnel, as well as
 Research scholars may also be allowed to enroll for their Ph.D./MTech. (Research)
 at KASHI INSTITUTE OF TECHNOLOGY, subject to availability of seats, research
 facilities and subject to their fulfilling eligibility criteria and all other academic
 regulations of KASHI INSTITUTE OF TECHNOLOGY. Further, PIRAMAL CAPITAL
 HOUSING FINANCE LTD. may request to design and teach a Course which it deems
 fit to enhance quality and performance of its employees. Such Courses may be run at
 any mutually convenient premises.



- f) PIRAMAL CAPITAL HOUSING FINANCE LTD. may seek
 assistance/guidance of KASHI INSTITUTE OF TECHNOLOGY
 faculty member/s in product/process modification, modernization, trouble
 shooting, etc or impart training of soft skills/hard skills to the Industry's employees.
- g) Would allow the industrial visits of students for half/full day to provide them with an exposure to various equipment, instrument, etc.
- PIRAMAL CAPITAL HOUSING FINANCE LTD. may showcase its business activities at the seminar/workshop/conference, etc. at KASHI INSTITUTE
 OF TECHNOLOGY only if they find it deem fit.
- PIRAMAL CAPITAL HOUSING FINANCE LTD. may avail library,
 Internet, computational facilities at KASHI INSTITUTE OF TECHNOLOGY.

ARTICLE-III: EFFECTIVE DATE AND DURATION OF MOU

- 1. This MOU shall be effective from the date of its approval by competent authorities at both ends.
- 2. The duration of the MOU shall be for a period of 5 years from the effective date.
- 3. Any clause or article of the MOU may be modified or amended by mutual agreement of PIRAMAL CAPITAL HOUSING FINANCE LTD. and KASHI INSTITUTE OF TECHNOLOGY.
- 4. No Financial aspects are to be covered in this agreement.
- 5. All above mentioned activities will come into action only after the prior permission from both the ends as and when required.
