



Responsibility Structures of Parties

- **KASHI INSTITUTE OF TECHNOLOGY** shall provide the infrastructure of computer systems, projector etc. for the Expert Lectures. Also the labs and other research equipment available in the lab.
- **TechXR Innovations Private Limited** shall be responsible for arrangements & coordination for supply of Industry Expertise, Design training program, process of necessary Appointments with Industries for Industry workshop Program, Expert Lectures as well as Visits in coordination with staff & HOD.
- **TechXR Innovations Private Limited** shall create awareness amongst students for promotion of the activity especially Internship Program.

Certification of Programs

Termination of 'MOU'
